3 It was confirmed that there were no Declarations of Interest from those attending the Meeting

4. John Martin presented a Report confirming that he had reviewed the Environmental Issues incorporated within the current N P as some Policies have changed in their presentation since that time. The Sub- Group of AC, MW and JM needed to look at the various aspects of each of the following categories, to see if there was a need to alter, amend or increase the references to various areas of the Village, including:

Local Green Spaces  
Important Open Space  
Sites/Features of Natural Environmental Significance  
Biodiversity  
Heritage Assets of Historical and Local Significance  
Listed Buildings  
Ridge and Furrow  
Local Heritage Assets

Additionally, there was a need to incorporate a proposed Policy on Renewable Energy.

All of the above would then be submitted to the Open Event at the Arnesby Village Hall on Saturday 11<sup>th</sup> February 10am-12pm on the basis that those attending and

expressing an opinion, should have an opportunity, to contribute to the Final Policies to be incorporated in the N P Review.

The sub-Group is to meet at MW's house at 10am on Monday 9<sup>th</sup> January 2023.

5. DRJ reported that GK and he had an on-line meeting with AECOM, who would assist with building up statistical and background information, housing needs survey and design criteria, to build into the relevant area of the Reviewed N P. An application had been submitted for funding for the costs and a decision awaited. Once approved, further meetings would take place to establish a Housing Policy, but it was stressed that this would be a Policy which would be determined by the balance of views following the Open Event on February 11<sup>th</sup>.

6. Discussions took place with regard to the Open Event. JM confirmed that Your Locale would present display material and the questions and response documents, so Parishioners attending could express their views. These would then provide the basis for the adoption of Policy amendments to be incorporated in the draft Reviewed N P. Flyers would need to be distributed around the village, notice given in the newsletter and the village web-site.

7. The next meeting of the Steering Group will take place on Thursday 19<sup>th</sup> January 2023 at 2.30pm at Sycamore Cottage, Arnesby, subject to confirmation by GK of his availability.
