Village Green Use Agreement

The User agrees to indemnify and hold harmless the Council, its officers, employees, and agents from any claims, liabilities, damages, or expenses arising from the User's use of the Village Green. c. The User shall obtain public liability insurance in the amount of \pounds _____ to cover any potential claims arising from their use of the Village Green. A copy of the insurance certificate shall be provided to the Council prior to the event.

4. Termination

The Council reserves the right to terminate this Agreement at any time if the User fails to comply with the terms and conditions set forth herein. In such case, the User shall immediately cease all activities and vacate the Village Green.

5. Force Majeure

Neither party shall be liable for any failure to perform its obligations under this Agreement due to circumstances beyond its reasonable control, including but not limited to acts of God, war, riot, civil commotion, or natural disaster.

6. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of The United Kingdom.

7. Entire Agreement

This Agreement constitutes the entire agreement between the parties and supersedes all prior understandings, agreements, or representations, whether oral or written, relating to the subject matter hereof.

8. Amendments

Any amendments or modifications to this Agreement must be in writing and signed by both parties.

9. Notices

All notices required or permitted under this Agreement shall be in writing and delivered personally or sent by registered mail to the addresses set forth below or such other address as either party may specify in writing.
