- 3. To approve minutes of the Parish Council meeting held on Tuesday 23rd July 2024.**
 - **Approved**
- 4. To consider matters arising from the Minutes of the Annual Parish meeting held on Tuesday 21st March 2024:**
 - Update on Severn Trent Water treatment plant.
 - David Johnstone is still working on getting answers.
 - To receive an update on the complaint from a parishioner regarding the new "Just Eat" sign outside of Little India.
 - The restaurant were contacted and the sign has been removed.
- 5. To approve minutes of the Parish Council meeting held on Thursday 29th August 2024.**
 - Approved
- 6. To receive a financial statement**
 - for 1 April 2024 to 31st August 2024 (paper APC/Sept24/1).
 - Approved. There were no exceptional items of expenditure in the period. The Parish Council currently holds £42,321.09 in surplus funds.
- 7. To receive a progress report with the Neighbourhood Plan review.**
 - There has been a slight delay in the process. The report is currently with the inspector, however, it has now been suggested that we will need to hold a referendum in November as the NP includes additional housing. David Johnstone is to include a piece in the Village Newsletter and will consider the need for flyers once details are finalised. HDC will run the referendum.
- 8. To consider planning matters.**
 - 24/01087/TCA - Works to trees (Fell), Land At Manor Farm, Lutterworth Road Arnesby (461580 292421)
 - Approved
- 9. To receive a report from District Councillor Neil Bannister.**
 - Not present
- 10. Open session for questions and future business.**
 - It was raised that there had been damage caused to the Village Playing Field by some users. Leigh Maidment to speak to those concerned and ask them to refrain.
 - Leigh Maidment informed those present that matters for consideration in next years budget should be submitted for discussion at the next Parish Council Meeting, 19/11/24.

- Leigh Maidment informed those present that we had received communication of an upcoming Public Transportation Consultation by HDC, but no details had yet been communicated.
- It was asked that now that the lease for the village playing field was agreed, would we be moving ahead with the plans for the community play area. Zandra Byatt will canvas opinion amongst parishioners.
- It was asked whether we had made any progress with the provision of a village First Aid course. Leigh Maidment advised that we hadn't had any take up from Parishioners, and numbers were needed before we could book something with the Red Cross. Leigh Maidment will restart communications with Red Cross to try again.
